

Information on the processing of images and personal data for the participation of minor children in the programs and media services of San Marino RTV

1. What does this document represent??

Hereby, we indicate how and for what reasons we collect your personal image and personal data, regarding your participation in television programs/journalistic reports made and aired by San Marino RTV.

2. What are the normative references?

- Law 21 dicembre 2018 no.171 of Republic of San Marino.
- General Data Protection Regulation 679/2016.
- Law 25 gennaio 1991 no. 8 e s.m. (Copyright protection), in details the articles 90-91-92.
- Italian Civil Code (article 10).
- Italian Law del 22 aprile 1941, no. 633 e s.m (Copyright protection), in details the articles 96 e 97.

3. Identity and contact details of the Data Controller

The Data Controller is the San Marino RTV S.p.A.- Radiotelevisione della Repubblica di San Marino (hereinafter also "Data Controller" or "San Marino RTV") legal entity under San Marino law that exercises its powers through the General Manager. The Data Controller is located at Viale J.F. Kennedy n.13, 47890, San Marino, Republic of San Marino and can be contacted for further information regarding the processing carried out at the following addresses: boccalatte@sanmarinortv.sm - 0549/882000.

4. Contact details of the Data Protection Officer

The Data Controller has appointed a Data Protection Officer who can be contacted by e-mail at: dpo@sanmarinortv.sm for any questions concerning the processing of your personal data.

5. For what reasons do we collect your image and personal data?

San Marino RTV collects your image and personal data for informational and journalistic purposes in the context of news programs and services, the recordings of which may be the subject of publication on the channels of San Marino RTV (television channel, website, social networks). Your personal identification data are collected in order to verify the correct manifestation of consent to processing.

6. When can we process your image and personal data?

San Marino RTV may collect and process Your Image and personal data for informational and journalistic purposes only on the basis of Your express, informed and explicit consent. The provision of your personal data is not mandatory just as it is not mandatory that Your Image be collected and processed as part of San Marino RTV's news programs and services. Refusal to provide consent to processing does not allow San Marino RTV to use your image and personal data for the purposes described above.

7. How long do we retain your image and personal data?

Your image and personal data are kept for as long as necessary to achieve the processing purposes indicated above. The Data Controller guarantees the interruption of the processing and the complete erasure of the processed data, if you exercise the revocation of the consent originally given, as well as in the case of exercising the right to object, if the legitimate interest of the Data Controller in storage does not prevail.

8. How are the processing carried out?

The use of your image and personal data is carried out in a way that does not harm your honor, reputation or decorum. The Data Controller processes your data, by means of media, magnetic, electronic and telematic, guaranteeing the security and confidentiality, as well as the accuracy, updating and relevance of the data to the stated purposes. Your data will also be processed by internal and external parties who are authorized to process by virtue of written acts containing the correct instructions to ensure adequate data protection. Your personal data are stored in the physical and computerized archives of the Data Controller within the Republic of San Marino. Your Image and personal data are subject to dissemination by means of the channels of San Marino RTV if you have consented to the processing.

9. What rights can You exercise?

The processing of your data is carried out on the basis of the principles of fairness, lawfulness, transparency, protection of confidentiality and the rights recognized to you. You have the opportunity to enforce the rights recognized to you by Regulation (EU) 2016/679 and Law No. 171 of December 21, 2018, such as the right to request access to the processed data, the right to data portability and the rectification or erasure of the same or the limitation of the processing concerning you, including the right



to propose notification and complaint to the competent supervisory authority. You are also granted the right to object to the processing of your data. Finally, we remind you that you are also recognized the right to revoke the consent given at any time, without prejudice to the processing that has taken place previously, by communicating your revocation by registered letter or an e-mail message to the Data Controller at the above address.

to respect and enforce the rules of good conduct and behavior such as, purely by way of example: 1. do not smoke or use open flames; 2. not access positions other than those assigned by the stage manager; 3. do not approach the edges of the stage; 4. always refer to the qualified technicians for the electrical and electronic components; 5. do not place material of any kind in the indicated escape routes; 6. do not enter the stage with sandals and/or uncovered shoes; 7. do not stand under pending loads or suspended elements, even at stage level, when they are moved; 8. do not access the stage unless indicated by one's contacts; 9. do not transit and/or stop in the stage construction and construction area where there is a danger of materials falling from above during the entire assembly and disassembly period; agree with the site technical director the areas where it is possible to operate;

- to exempt and release, with the signature of this document, *San Marino RTV and Media Evolution* and/or its assignees from any and all civil and/or criminal liability deriving from participation in the Festival, also for any accidents or injuries suffered and/or caused to themselves and/or third parties, including those deriving from the action of other participants, or for any damages of any kind and type to persons and/or things suffered and/or caused to myself and/or third parties, undertaking not to bring any judicial and/or extrajudicial action and in any case not to raise any objection regarding the organization of the Festival towards *San Marino RTV and Media Evolution* and its collaborators;
- to indemnify and hold *San Marino RTV and Media Evolution* and/or its assignees harmless from any damage, injury, loss, cost, expense (including legal) and sanction deriving from the violation by me and/or my collaborators of the rules set forth herein and those referred to in the Regulations published on the Festival website, which I declare that I have seen and know well, or deriving from negligent and/or malicious conduct;
- to assign and transfer to *only San Marino RTV*, in the person of the legal representative on a temporary basis, with registered office in Viale J.F. Kennedy, 13 Republic of San Marino, 47890, C.O.E. SM 4158:
 1. the right to film and/or photograph and/or record, also through authorized third parties, with television, cinematographic, photographic and phonographic means on film, tape or any other current or future invention medium, my image, my voice, my name and the artistic performance I performed throughout the Festival, with full right by *San Marino RTV* to reproduce, disseminate, transmit, make available, duplicate, process, couple, synchronize, print, publish and project the footage and/or photographs and/or recordings, both in their entirety and in part, jointly with the Festival or separately, with any medium currently known (by way of example only: terrestrial TV, satellite, cable, radio, web radio, web TV, social networks, internet, downloading, streaming, analogue and/or digital systems, DVB-T, DVB-H, DVB-X, online and offline, fixed and mobile telephony, UMTS, GPRS, HSDPA etc.), or which will be invented in the future, in any form and manner, without any limitation of time and/or space, through websites, web radio, web TV, social networks, etc., also through total and/or partial transfer to third parties and this for the entire duration of protection and for all countries of the world;
 2. the right to associate the aforementioned footage and/or photographs and/or recordings with

- advertising and/or promotional messages relating to the Festival and to make the most extensive advertising use of them;
3. the right to process all personal data I provided to the Festival for the purposes related to the performance of the same, as well as for all purposes, also of a promotional-advertising and/or commercial nature connected to it, expressly authorized by signing the Privacy Policy.
- that I have nothing to claim from *San Marino RTV* and/or its assignees in relation to the transfer and uses referred to above. *San Marino RTV* and its assignees, therefore, will be the owner of the video-phonograph of the above shots, photographs and recordings, as well as of all the aforesaid material eventually created.

I OBLIGE MYSELF

- to maintain confidentiality, until official communication has taken place, on the results of the Festival, acknowledging that in the event of non-compliance with this obligation, the penalty of disqualification from the Competition will be applied, as well as a fine as a penalty equal to € 15.000;
- to give consent to take photographs alone and in group with the other finalists and to grant interviews for the TV, to be used during the February 25 broadcast;
- in case of victory in the Competition, to register on behalf of the Republic of San Marino in the Eurovision Song Contest 2023, signing for this purpose all the necessary documentation, undertaking to comply with its obligations, fulfilments, formalities and deadlines for registration and doing everything necessary for the registration and participation in the Eurovision Song Contest 2023;
- if I win the Competition, to participate - compatibly with my commitments - as a guest, upon simple request and without payment of any remuneration, in the final evening of the next edition of the *Una Voce per San Marino Festival*.
